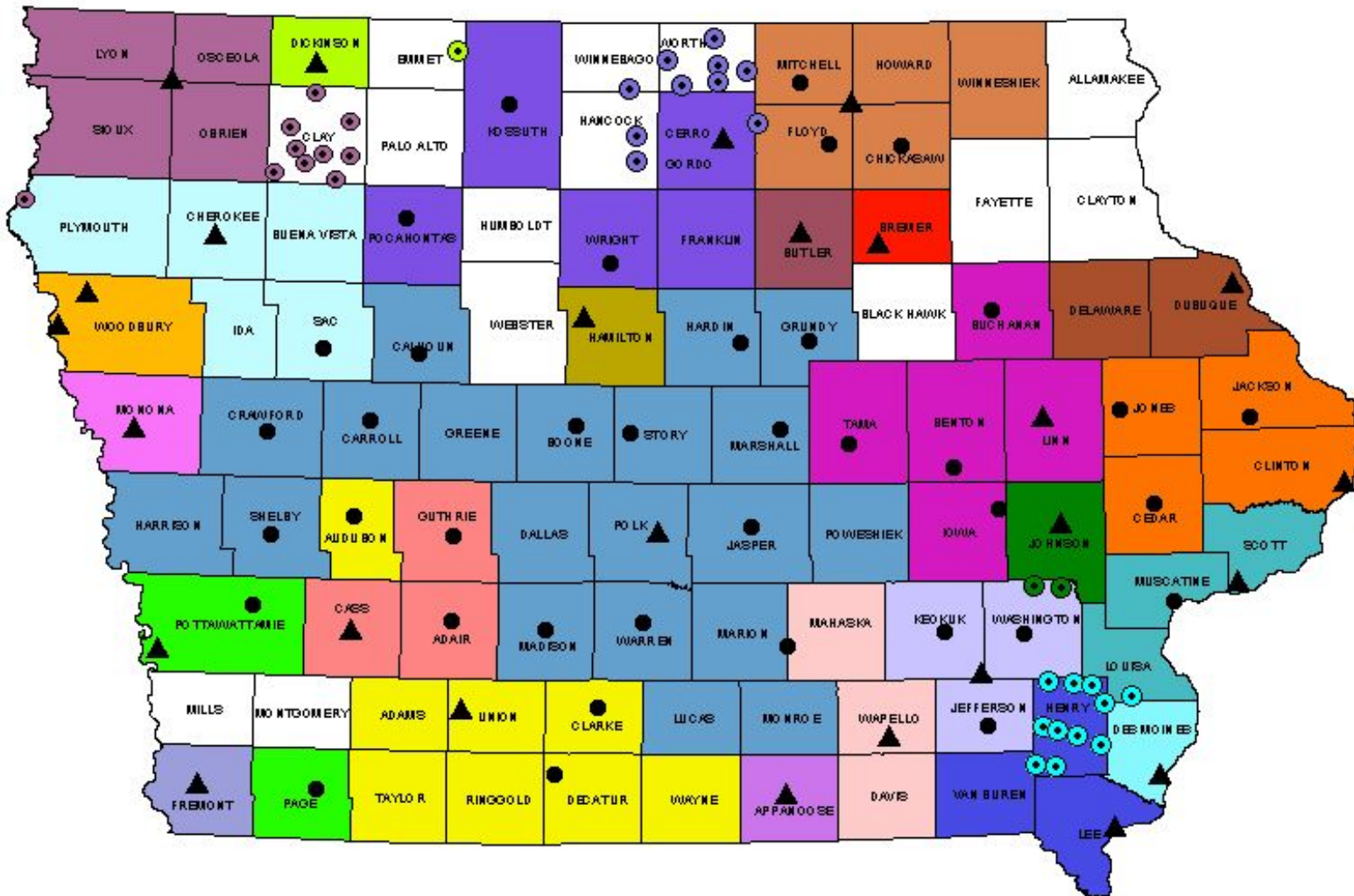


Regional Collection Centers
